Agenda-2 The University has received a work order to organize In-Service Teacher Training for PM SHRI Schools under the Government of Gujarat (GoG) and the Government of India (GoI), in accordance with Letter No. Samagra Shiksha/QISL/01/2025/2025-70180-182 dated 03/12/2025, The sanctioned budget for the training programme is as follows:

Agenda-3 The University proposes to organize training for Foundational Stage Teachers (Balvatika to Standards I & II) at Dakshinamurti Vidyarthi Bhavan, Bhavnagar, in view of the institution's long-standing legacy in pre-school education and its suitability for delivering quality training.

After discussions with the officials of the Dakshinamurti, the University has received a proposal detailing various maintenance expenses and resource utilization, as mentioned under Point No. 03 of the proposal.

The matter is placed before the committee for discussion and approval of the batch-wise cost payable to Dakshinamurti Vidyarthi Bhavan.

Resolution-3 The matter was discussed at length and resolved to discuss with the Dakshinamurti Vidyarthi Bhavan and keep the amount of Rs.7000/- in against to the proposed 8000/- per batch.

Agenda-4 The University has received a work order for PM SHRI Schools, as mentioned under Agenda Item 01. The University proposes to organize training programmes for teachers of Standards III to V, primarily at the University campus and, where necessary, at other suitable locations.

For this purpose, the University will establish subject-wise resource rooms to facilitate hands-on training for teachers.

The matter is placed before the committee for discussion and approval of the proposed expenditures to be incurred for this purpose, in accordance with university rules and from the budget provided under Samagra Shiksha.

Resolution-4 The matter was discussed and resolved to make the necessary expences from the amount received from the SSA grants and if require Hon'ble Vice Chancellor is empowered to make the suitable decision in this matter.

Agenda-5 The remuneration payable to experts engaged in the PM SHRI Schools teacher training programme is to be determined and placed for approval.

Resolution-5 The matter was discussed and resolved to pay Rs. 1500/- to the The Coordinator per day and Rs. 1000/- to the teacher per day for the training.


