- IQAC shall prepared 5 years Institutional Development Plan of the University as per UGC, State Government guidelines and CRU Act.
 - CAS for Engineering and Ayurveda teachers of the Children's Research University, the University should follow the guidelines which other State Public Universities such as M S University of Baroda, Gujarat Ayurveda University of Gujarat is following.
 - A Committee shall be formed to review the Work profile for the teachers and the same shall be incorporated in PBAS as the nature of the University is unique. The IQAC shall make the detailed presentation before 30th August, 2025.
 - The IQAC shall make the detailed planning of the workshop, FDPs, Orientation programme for the teaching



and non-teaching staff to prepare them for the NAAC assessment process.

Agenda: 05: The University has received application from faculties regarding transfer and deputation at other state public universities on the basis of lacking of teaching work due to the change in objective of the University in 2023. The matter is put for discussion and approval to forward the proposal to the Education Department for consideration. **(Establishment Branch)**

Resolution: 05: The matter regarding the applications received from the Children's Research University teachers for seeking transfer to other state public universities of Gujarat on account of lack of teaching work, family reasons and amendment in the University act in September 2023, all the members of the council discussed at length and unanimously resolved to forward the proposal of transfer with recommendations for all the 10 teachers whose applications are received till date (12/8/2025) to the Education Department for necessary actions. **(Establishment Branch)**
